SPECIAL RELIGIOUS INSTRUCTION

Throughout your child's schooling, the school will be arranging head lice inspections of students.

The management of head lice infection works best when all children are involved in our screening program.

The school is aware that this can be a sensitive issue and is committed to maintaining student confidentiality and avoiding stigmatisation.

The inspections of students will be conducted by a trained parent approved by the principal and school council.

Before any inspections are conducted the person conducting the inspections will explain to all students what is being done and why and it will be emphasised to students that the presence of head lice in their hair does not mean that their hair is less clean or well kept than anyone else's. It will also be pointed out that head lice can be itchy and annoying and if you know you have got them, you can do something about it.

The person conducting the inspections will check through each student's hair to see if any lice or eggs are present and a note will be sent home indicating that a check has been carried out.

In cases where head lice are found, the person inspecting the student will inform the principal. The school will make appropriate contact with the parents/guardians/carers.

Please note that health regulations require that where a child has head lice, that child should not return to school until appropriate treatment has commenced. The school may request the completion of an 'action taken form', which requires parents/guardians/carers to nominate if and when the treatment has started.

GENERAL INFORMATION

Head lice have been around for many thousands of years. Anyone can get head lice and given the chance, head lice move from head to head without discrimination.

Head lice are small, wingless, blood sucking insects. Their colour varies from whitish-brown to reddish-brown. Head lice only survive on humans. People get head lice from direct hair to hair contact with another person who has head lice. They do not have wings or jumping legs so they cannot fly or jump from head to head. They can only crawl.

Please follow the steps below to help us reduce the incidence of head lice at Bittern Primary School.

1. Prevention

Prevention is obviously better than cure and all parents should be made aware that head lice are difficult to prevent. There are no products that will prevent head lice. Tying back long hair at school may be useful.

2. Checking

Regular checking of hair is the best way parents can detect head lice early, so that treatment can be commenced. Parents are encouraged to check their children's hair at least weekly and if there are any outbreaks at school they should check daily.

3. Treatment

There have been changes to the way we treat head lice and nits. School exclusion is still necessary only if the child has live lice. If eggs and/or live lice are found, treatment must be commenced before the child returns to school the following day. All eggs must be removed (may take several days if there are many).

We now know that lice only live on the human head and do not live in bedding, pillows, couches etc. so it is important that time is not wasted cleaning the bedding and house in preference to dealing with live lice and removing all the eggs. The latest pamphlet from the Department of Human Services gives parents an optional way of treating head lice, without chemicals, using a head lice comb and hair conditioner.
